

# **DONATION GUIDE**



Below are instructions on how to make a gift through Birdies for Charity (minimum donation of \$25). All gifts will be bonused by 10%. The final day to donate is October 18, 2020.

## **DONATE ONLINE** (Mastercard, Visa and American Express are accepted. Credit Card Fees Apply.)

- 1. Visit https://bit.ly/2Vql6Ll and click "Birdies for Charity" under the "Charity" tab, then "Donate Now."
- 2. Enter the donation amount and select Goochland Pet Lovers from the drop-down menu, if necessary, and fill out the billing information form.
- 3. Donations are processed immediately, and donors will receive a confirmation email from PGA TOUR Charities, Inc. that will serve as a receipt for tax-deduction purposes.

Note: Gift charges will show as PGA TOUR Charities, Inc. (Tel: 1-904-285-3700) on credit card statements.

## DONATE DONOR ADVISED FUNDS AT COMMUNITY FOUNDATION FOR A GREATER RICHMOND

- 1. Log into the Donor Connect portal and select PGA TOUR Charities Inc. for the grant recommendation.
- 2. Designate Goochland Pet Lovers in the grant purpose section and follow the prompts to complete the request.
- 3. Community Foundation for a greater Richmond will complete the request by mailing the donation check and grant memorandum to the Dominion Energy Charity Classic office.

## DONATE STOCK

- 1. Complete the PGA TOUR Charities, Inc. Stock Transfer (DTC) Instruction Form and initiate the stock transfer.
- 2. Send the completed form to Community Outreach Coordinator, Kali Edsall, at <u>kaliedsall@pgatourhq.com</u>.

Note: Gift value and bonus are determined based on market highs and lows and gains or losses experienced.

#### DONATE REQUIRED MINIMUM DISTRIBUTIONS FROM AN INDIVIDUAL RETIREMENT ACCOUNT (IRA)

\* Donors aged 70.5 and older can donate funds from their annual required minimum distribution from an IRA account through Birdies for Charity.

- 1. Ask your IRA Fund Manager to issue a check in the desired amount to PGA TOUR Charities Inc. and designate (insert
